NEW BUSINESS FOR CONSIDERATION AND ACTION THIS EVENING

Resolution 22-206

Consider approving payment to Spring Electric under Contract #5 for the Ballston Lake Sewer District in the amount of \$17,670.00 for work completed.

Resolution 22-207

Consider approving payment to Trinity Construction under Contract #1 for the Ballston Lake Sewer District in the amount of \$275,133.86 for work completed.

Resolution 22-208

Consider setting a Public Hearing for Tuesday, August 9, 2022, at 6:15 p.m. on a lease option agreement between the Town of Ballston and Vertical Bridge to erect a cell tower on Town property adjacent to the Highway garage.

Resolution 22-209

Consider approving the extension and expansion of the Ballston Consolidated Water District to include Tax Map ID#s 239.-2-38.3 and 239.-2-38.4.

Resolution 22-210

Consider approving the receipt of \$534,203.51 representing tranche #2 of the Federal American Recovery Plan Act funds.

Resolution 22-211

Consider approving a reallocation of budget authority in the 2022 Final budgets for Funds A, B, Highway, Consolidated Water, and Morningdale Court Water from the “Contingency Budgeting Account” to the “Unallocated Insurance” expense account in the amount of \$1,925.10 for Fund A, \$1,768.00 for Fund B, \$6,428.61 for Highway Fund, \$1,430.45 for Consolidated Water, and \$62.10 for Morningdale Court to adjust for higher than anticipated insurance expenditures for the remainder of 2022. There will be no impact to fund balance for Fund A, B, Highway, Consolidated Water, or Morningdale Court.

Resolution 22-212

Consider approving a supplemental appropriation for the Paradowski Water and Jenkins Park 2022 final budgets to increase the “Budgeted Fund Balance Draw” revenue accounts and the “Unallocated Insurance” expense accounts by \$27.04 for Paradowski Water, and \$11.66 for Jenkins Park, respectively. The source of the \$27.04 will be Paradowski Water Fund, fund balance, and the source of the \$11.66 will be Jenkins Park Fund, fund balance.
